AAUW St. Paul Members Continue Tradition of Generous Giving During Health Crisis

As our History Theatre outing schedule came to an abrupt halt this spring, we had an opportunity to support the History Theatre as it struggled with a lost half-season. Sixteen of our members, with reservations pending for as many as three more plays at \$25 per seat, decided to give the cost of their tickets to the History Theatre as donations. As a group, those 16 are giving a total of \$875. Additional donations of \$75 are going to the Scholarship Trust and \$25 to the branch.

At the same time, we have \$877 in SignUpGenius reservations for lunches and evening programs that were cancelled in March. The 27 women who were offered a refund are choosing---the majority---to donate their refunds. We have \$311 in donations for the Scholarship Trust, \$142 for the branch, and \$213 for the House Preservation Fund. We await the distribution decisions for another \$69.

St. Paul AAUW has been exceedingly generous in their assistance to schoolchildren in St. Paul. This summer, as you might clean out closets and travel, please remember the disadvantaged



children returning to school in the fall. In preparation for the cold season, there are many children, some of whom are couch surfing on a nightly basis, or completely homeless, who will need hats, gloves, jackets, and boots of all sizes, from toddlers to teens.

In addition, I have been reminded that the students without a permanent space to sleep at night must also carry their personal care items in their backpacks. Therefore, as you travel, please collect travel-size soaps, shampoos, toothpaste, and toothbrushes. We can also use socks, hand wipes, facial tissue packets, wrapped sanitary napkins, and ChapStick®. I am certain the girls especially, will appreciate your gifts of personal care and hygiene products. We can assemble packets in the fall to distribute to St. Paul schools.

Children love stickers! They may come in your mail from organizations like Easter seals, national parks, and St. Jude. Teachers use these stickers to encourage their young students to do well on their assignments. Stickers that have positive messages such as *good job reading, smiley faces, happy greetings or you're great*! etc., are especially welcome. If you have stickers, please bring them in the fall too, or contact me.

We must continue to encourage our youth! Thanks so much for all your help.

Mar. 24, 2020 The Lost Man by Jane Harper

In Queensland, Australia, ranches are enormous, your nearest neighbor might be three miles away, and the sun and wind are unrelenting. In this challenging location, one of three brothers is found dead in a desolate spot where he had no reason to be. Was his death natural, or foul play? With no clues, it is difficult to find the answer.

April 7, 2020 The Missing Corpse by Jean-Luc Bannale

Most everything you've ever wanted to know about Bretagne (Brittany), or oysters, will be revealed to you as this perplexing mystery unfolds. Police Commissaire Dupin spends four frenzied days trying to track down a body that disappeared only hours after being discovered in Belon, on the Atlantic coast of France. The story he disentangles is logical, but complicated.

May 26, 2020 This Tender Land by William Kent Krueger

Minnesota, in 1932, was in the midst of the Depression, a hard time to endure even if you weren't an orphan at the Lincoln Indian School, and weren't even Native American like all the other students. This is the story of how four of the children escaped, planning to canoe down the Mississippi to St. Louis, where their only relative lived. Many smaller mysteries are encountered along the way, but the biggest is: How can—and will--they get there?

Body In The Wake by

Faith Fairchild has an exceptional habit of finding dead bodies. Expecting to spend a relaxing summer in the Fairchild summer cottage on Sanpere Island off the coast of Maine, Faith and her friend swim into a drowned victim, which sets off a whole set of unanticipated problems: involving preparations for a big Labor Day wedding, horrible new neighbors, and a couple more dead bodies.

July 28, 2020 After She's Gone by Camilla Grebe

A small town in the forested hills of south-central Sweden has lost its textile factory, iron mine, and machine factory. It's moldering away with immigrant refugees living in the deserted buildings, and the Swedes grumbling about the government paying for food, lodging, and education for the refugees, when it hasn't helped those who have always lived there. Then cold cases are reopened. Are the townsfolk responsible for the dead or missing residents?

Aug. 25, 2020 What Rose Forgot by Nevada Barr

Why is Rose in a hospital gown? The reason is finally explained as Rose and her plucky granddaughter manage to figure out what's going on, and how to stop the nefarious maneuvers from continuing. Think "Miss Marple" and "Nancy Drew," in a 2020-style in a memorable story.

New fireplace doors have been ordered for the library and the dining room. A new-to-us but gently used table was purchased for outside the Great Hall doors to be used for wedding gifts. The new sofa arrived in February. New windows for the sunroom have been ordered. After they are installed, the sunroom will be painted, and we are looking forward to finding a rug and some outdoor furniture to add to the ambience.


